Nkomazi Municipality stripped Naked of its leadership

The ANC in Mpumalanga have expelled it's mayor and speaker of the Nkomazi local municipality for defying the party.

Johan Mkhatshwa (mayor) Siphiwe Mashele (speaker) who have been mayor and speaker in the previous administration defied the ANC cocas in November last year and stood as mayor and speaking winning their positions back regardless of the ANC telling then not to stand for the position. Mkhatshwa who was supposed to be replaced by Phindile Magagula went to beat her with votes in a council meeting in November and Mashele also defied the party and contested Hilda Nyambi to become a speaker again.

According to acting secretary of the ANC in Mpumalanga, Lindiwe Ntshalintshali the two refused to resign after they were elected hence disciplinary actions were taken against them and four

more councilors.

The councilors who were also fired are: Mumsie Jeanet Khoza, Delile Thembelihle Mlangeni, Jacob Mancoba Mthethwa and Vincent Tshepo Nyambi.

They are accused of nominating and seconding the nomination of Mkhatshwa and Mashele during the council sitting in November 23 last year.

In a letter that Emsamo News have seen directed to the six, the disciplinary committee found them guilty and expelled them.

"The six have defied the organisation, Mkhatshwa didn't emerge in the mayor's interviews but he went to contest and that's a serious misconduct defying the party that he represents in the council.

We had to take them through all the processes of DC and a verdict was reached that they be expelled.

> The letters have been served to them and what's left now for the organisation is to

vrite to the independent electoral commission to

inform them that these people have been fired in the party and we shall then convene a special council sitting to elect the rightful mayor and speaker," said Ntshalintshali.

Ntshalintshali said from the four councilors the ANC is ready to go for by-elections.

"Remember for the

mayor and speaker we don't need to go for by-elections because they entered through propositional representation (PR) we shall just remove their names from IEC and forward the rightful names.

Those who are ward councilors from the four who nominated and supported the nomination we are ready for by-elections to retain our wards," said Ntshalintshali

Mkhatshwa could not be reached for comment nor did he respond to smses sent

Speaking on the sideline at the South African Local Government Association (SALGA) meeting in Cape Town Mashele told Emsamo News that she doesn't believe that someone can fire her because she joined the ANC alone.

"Hawuuu!! I don't know that, but I don't think someone can fire me because I joined the ANC alone. I will check with the others if they are fired but for me no, there's no one who can fire me from the ANC," said Mashele laughing.

Police find more clues at failed CIT robbery in Delmas

The high rate of CIT robberies in Mpumalanga has never given residents of the province peace daily when travelling on the road as they never know what may happen in front of them.

The Mpumalanga police have in Delmas, managed to pursue suspects in a cash-in-transit robbery, arresting two of the alleged criminals while other two were fatally wounded during a shootout with the police.

According to police report, a cash delivery van with two security guards was attacked by a group of heavily armed suspects.

Provincial police spokesperson, Brigadier Selvy Mohlala confirmed the shoot out and said a group of alleged criminals was cornered on the R42 Road in Delmas, after the attack.

"According to police report, a cash delivery van with two security guards was attacked by a group of heavily armed suspects.

The suspects then tried to rob the guards of cash but their efforts were futile," said Mohlala.

The police defended themselves whereby two suspects were fatally shot while two other suspects reportedly hijacked a Toyota Quantum minibus.

Mohlala says the rest of the suspects in the group managed to flee the scene of the ordeal, however investigations on the matter are still continuing.

The Provincial Commissioner of the

Peace at last as trial date is set for former Agriculture MEC

The trial date for the double murder charges and attempted murder against former agricultural MEC in Mpumalanga, Mandla Msibi is set to start in September.

Msibi and other five, Njabulo Shugulugu Mkhonto, Buddah Mdluli, Anele Mnisi, Tsepo Matsane and Charlie Ngwenya are facing two counts of murder and an attempted murder case.

Their arrest came after an August 22 incident outside Coyotes Shisa Nyama in Mbombela in which Sindela Sipho Lubisi and Dingaan Ngwenya were killed. Sfiso Mpila was also injured.

The suspects on the trial all pleaded not guilty and are out on a R20, 000 bail each.

Their case was postponed on Thursday last week for the state in finalize their indictment and set a trial date.

In a brief appearance on Tuesday state prosecutor, Leane Jones asked the court to

transfer the case to the high court for trial citing that the defense have been handed with the indictment.

Magistrate Eddie Hall transferred the

case to the high court where the dates have been set for September 5 to September 16. "The case is transferred to the

Mpumalanga high court to sit on September 5 to September 16. You are warned to appear and you bail is being extended," said Hall.

In the Indictment which Emsamo News have seen a copy of, all the accuse are charged with double murder and attempted murder.

Speaking to his supporters which filled the court room an dancing and chanting outside the court Msibi said he was happy that finally the case have been moved for a trial.

"We are happy that the trial date has been set, from the 5th to the 17th of September. There's no day that does not arrive, now we will have a chance to clear ourselves unlike the court of public opinion which have declared us guilty. We will respect the law as we did and going forward the court shall hear our case," said Msibi.

Outside the court there was a stage set for Msibi to speak and the Bester street was closed in the period where Msibi was appearing in court.

It's unclear if Msibi will contest the treasury position of the ANC on March 11 to 13 where the ANC provincial conference is expected to sit since has stepped aside.

Before his arrest Msibi was MEC for agriculture and also provincial elections manager of the ANC.

JOB CREATION INITIATIVES

- Mpumalanga Economic Reconstruction and Recovery Plan (MERRP) to place the provincial economy on a growth trajectory that creates more job opportunities for the people of Mpumalanga.

BULK WATER INFRASTRUCTURE

A Standerton father of a child who got paralysed by a massive tree at school is still looking for answers as the Mpumalanga department of education "refuses" to say what really

happened on the day. Melokuhle Shabalala, a Grade 3 learner, is lucky to be alive after surviving a horrific incident of a tree that fell on him while he was standing in a queue for food. The incident,

happened in November 2021 at Nyandeni Primary School in the Standerton township.

which left

him paralysed,

Nine-year-old Melokuhle was left paralysed and wheelchair-bound with fewer chances of walking again. He had to be transferred to the Witbank Provincial Hospital after spending several hours at the Standerton Provincial Hospital.

Distraught father Nkosana Shabalala said the department has since kept him in the dark as to what had happened to his

"It's so painful that up until now I still do not know how the incident happened

he told the reporter."I can barely eat and sleep when I see him lying in bed every day thinking he will never walk again," said an emotional Nkosana.

Since the schools reopened in January 2022, Melokuhle could not attend school due to his condition.

"He is always asking me when he will go back to school every morning when he sees his sister Mpilwenhle preparing to go to school,"

the father said.


Nkosana said the department is refusing to share with him the report as well as the video of the incident.


'This is what pains me a lot because it denies me the right to know what happened. Why are they hiding from me?" asked the father. Education department spokesman Jasper Zwane told 013NEWS that the

matter is in a process of going to court. "The matter is now handled by lawyers of the department and those representing the family," Zwane said.
